On April 2, 2004, the Africa Overseer, Brother Paul Akazue, in the company of his wife, Jane; Brothers John Aina and Emmanuel Moh, left Lagos, Nigeria, for a missionary trip to Eastern and Southern Africa. Their first port of call was Kenya, where they were met on arrival at the Jomo Kenyatta International Airport by a team of six, including the Kenyan Overseer, Brother David Mungai; the General Secretary, Brother Peter Gatimo and his wife; two other ministers and Brother Emmanuel Umana, who is a Nigerian based in Kenya.

On April 3, the team left for a branch church at Thogoto. The General Secretary informed the missionary team that the Thogoto branch church was the pioneer branch of The Apostolic Faith in Kenya and was the place visited about 27 years before by Brother Loyce C. Carver, the former General Overseer of the Apostolic Faith. They noted that the Church had had series of problems, which created setbacks and led to a break in communication between the Kenyan Church and both the International and Africa Headquarters. The prevailing situation ushered in different ways of worship in Kenya, which were quite different from The Apostolic Faith pattern. However, in 2002, a team of 19 from

On Sunday, April 4, the team visited Bahati, Nairobi. Other places visited included Ngong town and Muguga. The following Monday, the Africa Overseer had a meeting with all the ministers from the branch churches in Kenya. At the meeting, he gave out copies of *Gospel News in Africa, Camp Meeting Teachings*, tracts, pocket calendars and other Gospel materials. Topics covered at the meeting included: The History of The Apostolic Faith Church, Doctrines of The Bible as Practised by The Apostolic Faith Church, Sunday School Classifications and On-going Projects in Nigeria. gathering that the team was leaving for Zambia and South Africa the following day, but would return to Kenya before going back to Nigeria.

The team arrived Lusaka, Zambia, on April 6, to join them in their annual camp meeting. The Director of the Foreign Work at the International Head-Brother Dwight quarters, Baltzell, accompanied by Brother Cliff Paulsen, joined the Zambia Camp meeting on April 17. Other delegates also came from South Africa, Botswana, Zimbabwe, Tanzania, Kenya and different parts of Zambia. On the evening of Wednesday, April 7, after a special song-Come, Great Deliverer, Comewas rendered by a Sister, the Holy Ghost power fell in the old Apostolic manner. The preacher could do nothing more than simply invite the seekers to the mourners' bench . It was a glorious experience. Many received their Christian experiences. 86 souls were later baptised in water.

The Easter Musical Concert was held in the evening of April 11, with 2,170 in attendance. As the choir rendered their last piece, people rushed to the altar and the power of God was greatly manifested.

The team left for South Africa on April 19. Many branch churches in different regions of South Africa were visited in the company of their Overseer, Eddie Brother Sadik. Churches visited included Orlando, Soweto; Pietersburg; Makhado; Durban and Tembisa. At each station, Brother Akazue exhorted the brethren and prayed for them. On April 25, the team

worshipped at the Orlando Headquarters church and Brother Akazue gave a teaching on *The Home,* There was a youth forum later in the afternoon, where the vouths asked questions and had responses to many of their nagging problems. The Music Director, Brother John Aina, also had some time to groom the choir

and assign instruments to some aspiring instrumentalists. Many South Africans were richly blessed during this visit and on the last night in South Africa, a lady in the mission house was saved.

The Gospel team returned to Nairobi, Kenya, on April 27. A leaders' conference was arranged at Naivasha on Friday, April 30. In the morning of the day, Brother Akazue spoke on *The Principles of a Stable and Growing Church*. This was followed by another challenge in the afternoon on *The Gospel Call, Your Love and Your Faith*. The question and answer session which followed, was very rewarding. After lunch, the Af-

rica Overseer had another session with the pastors, while other team members were assigned to other groups to lead discussions on various challenging issues. A group photograph rounded up the day's activities. #### **Cote D'Ivoire**

## across nigeria

#### Lagos State

There is early morning campaign in many of our branch churches in Lagos State. This involves distribution of Gospel literature and invitation of people to services. The effort has yielded much fruit and the attendance at services has increased.

At Idiroko town, on March 18, 2004, a new church was dedicated. In spite of the initial difficulties, God gave the victory. The service was a revival that resulted in salvation of souls. On April 14, 2004, a new Bible Study centre was dedicated.

At Owode-Yewa, in one of the revival services, God opened the ears of a deaf man, saved, sanctified and baptised him with the Holy Ghost.

At Sango Ota, a brother was healed of stroke after praying and trusting God for over 7 months.

At Aboru, God purchased a parcel of land for the Church as well as electronic equipment. A brother testified of Divine deliverance from a fire outbreak on July 9, 2003. He jumped down from the 6th floor of the Nigerian Industrial Development Bank building and God was there to receive him safely on landing.

A sister who had been childless for a long time and had suffered from spiritualists, testified that God saved her. God also blessed her with a bouncing baby boy.

At Apapa Ajegunle, a brother testified of Divine healing from a prolonged illness that affected his brain and lasted for over one year.

At Ikorodu, God continued to bless souls with different Christian experiences. He also provided a new bus and an electronic organ for the Gospel work. The Gospel has reached Bayeku and a Bible study centre will soon be opened there.

#### **Uyo District**

God has visited the district with copious blessings. 57 souls were saved, 14 sanctified and 7 baptised with the Holy Ghost and fire. A total of 31 people were also healed of diverse sicknesses.

God delivered one of the ministers, Brother Patrick Okon, who is a mason by profession, from earth slide which buried him alive in the course of his work. God also delivered another brother from a burning car. He sent passers-by to help him to put off the fire and preserved the car.

A dead child at Mbierebe church was raised to life. God cast out the demonic spirit from one lady in Nkara Obio church. There is nothing God cannot do.

#### **Ondo/Ekiti**

Revival meetings were held from March 21 to 28, 2004, at the Town Hall, Iyin-Ekiti, at the invitation of His Royal Highness, Oluyin of Iyin-Ekiti. Virtually, the whole town was in attendance, the Oba and his chiefs, inclusive. The revival commenced with a musical concert and it was greatly blessed. A total of 24 souls were saved, 6 sanctified and 1 healed.

The highlights included: the miraculous healing of a man with a withered hand who had suffered for 10 years. He leapt and shouted for joy, raising the hand for everyone to see.

A large parcel of land was donated to the Church for the establishment of a College of Technology, while the large modern town hall was temporarily released for church services.

On Easter Sunday, at Ajilosun, Ado Ekiti, there was an unprecedented mighty revival throughout the morning, afternoon and evening services. A total of 46 blessings were recorded. This included 27 saved and 13 sanctified.

The revival meetings in Ondo State lasted for five weeks, from March 28 to April 25, 2004. It involved fifty branch churches. In the pattern of Jesus' commission to the seventy, ministers were assigned to take up the services in the branch churches. God worked with them and wonderful blessings were reported. 534 souls were saved, 264 sanctified, 73 baptised with the Holy Ghost and fire and 43 healed.

The testimonies among others included: the restoration of a backslider at Ondo, who had left the fold for 25 years. She was saved, sanctified and baptised. Her eldest daughter also prayed through to salvation and sanctification. An elderly woman, certified dead for hours was also restored to life. A sister at Okesa, Ado Ekiti, testified of being healed after heavenly visitors performed a surgical operation on her ailing body. God used a teenage Sunday School boy to reach a woman at Ado Ekiti. She came to church and prayed through to salvation.

God provided a piece of land at Ilu Omoba for a new place of worship.

At Okeigbo, God healed a brother of an unknown illness. A sister also testified that God is a great provider. He changed the poverty situation in her family for the better. Another brother who was bitten by a poisonous snake, testified of the power of God to heal and deliver.

#### Ogun

The month of April was set aside for revival in eight churches: Iwopin, Olugbo, Ogunmakin, Itoku-Aro, Ayetoro, Imasayi, Owode-Egba and Odeda. Services were held for two days at each station. The revival was blessed. 71 people were saved, 29 sanctified, 6 baptised with Holy Ghost and 5 people were healed.

At Ogunmakin, the elder brother of late Brother Madeinlo testified that Jesus called him by name and urged him not to resist His entreaties any longer. He was saved during the revival. The 80-year old mother of the resident minister persisted in prayer and was wonderfully saved too. At Orunwa, a leader of the *Osun* worshippers prayed through to salvation and sanctification and denounced her former appellation which had bearing with Osun deity.

At Sagamu, an aged woman prayed through to salvation and sanctification during one of the revival services.

At Ijebu-Ode, a lady heard a voice directing her from her house to the Church. She obeyed and was wonderfully saved.

At Imasayi, a drug addict and vendor of hard drugs was saved.

At Itori Oke, a sister testified that God restored life to her sister who had been unconscious from an illness that doctors declared hopeless. A brother also testified that through prayer, God delivered a man, who had been hired to work on a 45-feet deep well when he was stuck in the well. The Fire Brigade had been invited but had failed to bring him up.

### **Staying Through With God**

In 1953, after a Sunday service at The Apostolic Church, Okoro-Gbede, Brother David Oloruntoba, who had attended The Apostolic Faith Church in Lagos, gave the inspiring news of the Lagos service to his people. Those who were present in the after-service meeting at Okoro-Gbede ind Т u е d С Mr M. A. B. Kunle. Brother Oloruntoba explained how the meeting in The Apostolic Faith Church was orderly and highly inspiring. He urged that he and his colleagues should write to the Church to establish a branch at Aye-Gbede. Brother

Kunle was given the address of the Church and mandated to write the Headquarters on behalf of all the others.

The letter from Aye was promptly replied by the Lagos Headquarters of The Apostolic Faith Church, and a date was

set for a Gospel tour of the area. Kunle met the team near a brook close to Okoro-Gbede. Observing that a vehicle stuck in the mud, near the brook, was that of their invited guests, he quickly gave them a helping hand and directed them towards the road to Aye.

Brother Kunle got saved in 1954. He faced a lot of persecution and problems, but through patience and perseverance he endured it all. He took a definite stand for the Gospel and through him The Apostolic Faith was established in Aye and Aiyetoro-Gbede.

He was the first pastor in those churches. Brother Kunle was the first Apostolic Faith worker in the Northern Region. With some Gospel workers assisting him, he visited many primary and secondary schools in Ijumu, Kabba Land, in his effort to spread the Gospel. He started the school visitation programme in Kabba in 1960 and later on he worked with Brothers Michael O. Onavemi, Augus-Omole tus 0. a n d Solomon Olorungbon, for many years until the work was given the name, Association of Visiting Secretaries (A.V.S). The work extended to Iyagba Area in Kabba Province, which later extended to the Colleges, Universities and other Higher Institutions. With motorcycles and bicycles they spread the Gospel to all the nooks and crannies of Kabba Land. One cannot but praise God for his humble life as Brother Kunle readily enlisted for voluntary duties in the House of God. He was

ever ready to undertake any humble duty.

He was appointed a minister and later became the Overseer of Kwara State before he was transferred to former Ondo State. He retired from active service due to ill health.

He breathed his last in the early hours of April 24, and was laid to rest on May 27, 2004.

He was a baritone soloist, a trumpeter and trumpet teacher. He was a preacher and a teacher. He was the Secretary Treasurer for this organisation for many years. But above all these, **Samuel Oluyemisi Adebanjo Odumosu**, served diligently and quietly

### In the Lord's Service

One evening in 1959, a young man on his way to a dancing hall met a friend who was already saved. That young man was Samuel Oluyemisi Odumosu. His friend invited him to church and told him of the power of the Lord to save.

Though Samuel did not believe him at first, he eventually followed him to the church.

There, Samuel met Jesus Who turned his life around. Gone were the dancing lessons and other ungodly acts. Samuel prayed and obtained the three Christian experiences and joined the music class. On February 26, 1963, Samuel became a member of the senior choir and orchestra. For many years after this, he faithfully and quietly carried out his duties.

Brother Odumosu became a Sunday School teacher in 1970 and later became a minister of the Word. For he many years taught music classes and generally assisted the Music Director, working effectively but unnoticed. He

was dutiful and meticulous yet friendly and courteous. With the help of Sister Christianah Modupe Odumosu, whom he married on February 6, 1975, he laboured faithfully on.

He was always willing to give a solo when requested to. His familiar solo numbers included: *Mary's Boy Child; Gbogbo Aiye Gbe Jesu Ga; I Have Found a Friend in Jesus; Jesus Calls Us O'er the Tumult; Telephone to Heaven; The Trumpet Shall Sound; Keep Looking Up* and many others. He sang in the Victory Quartet with his friend, Brother Paul Ibikunle, who had gone on before him. His last vocal solo in the church was *I'm On My Journey Home,* a song which he sang with tears running down his cheeks.

Out of his determination to give the balance of his life to God, He became a full-time worker of The Apostolic Faith Church on September 1, 1993, and he worked in the Treasury Depart-

ment. On February 14, 1998, he was appointed the Secretary/Treasurer of the Church and Secretary to the Board of Trustees.

On Saturday March 13, 2004, he travelled in the company of his wife, Dupe, and two other brethren to his home town, Odo-Senbora, to witness the establishment of a branch church in the town. The new branch church started in his father's compound at Oke-Ita, Odo-Senbora, on Sunday, March 14, 2004. Burdened for the salvation of his town's

> men, he went round inviting people to the revival service. Many people prayed through to different Christian experiences, while others received various blessings from God.

When he came back to Lagos, he told the driver

who brought him from Odo-Senbora: "Mission Accomplished". He was ill for a few days. His common song during the illness was, *Lord I'm Coming Home*. His wife reported that during the illness, he was always talking of Heaven. He prayed together with his wife throughout the night preceding his death. He prayed that God would make it possible for his wife and children to make the Rapture. On March 23, 2004, at about 2:00 am, he passed on to Glory.
